**AGE DISCRIMINATION IN EMPLOYMENT**

**ACT—JUDICIAL INTERPRETATION OF THE BONA FIDE OCCUPATIONAL QUALIFICATION EXCEPTION—**

In an action brought under the Age Discrimination in Employment Act, a bona fide occupational qualification defense is available only if the defendant can establish, by a preponderance of the evidence, that the age qualification is reasonably necessary to the normal operation of the particular business.
