## ERRATUM

In John B. Austin, *A General Framework for Analyzing Choice-of-Law-Problems in Air Crash Litigation*, 58 J. AIR L. & Com. 909 (1993), the first sentence of footnote 154 on page 972 should read:

Although *Paris Air Crash* cites *Reich v. Purcell*, 432 P.2d 727 (Cal. 1967), and *Hurtado* to support its ruling that foreign jurisdictions would have no interest in limiting their residents' recovery, *Paris Air Crash*, 399 F. Supp. at 742-43, the reasoning in these cases does not extend to the situation in *Paris Air Crash*.
