A Bibliography of Commentaries on the United Nations International Sales Convention†

The U.N. Convention on Contracts for the International Sale of Goods will come into force on January 1, 1988. Italy, the People's Republic of China, and the United States deposited instruments of ratification with the U.N. Secretary General on December 11, 1986. These three countries join eight states that were already parties to the Convention: Argentina, Egypt, France, Hungary, Lesotho, Syria, Yugoslavia, and Zambia. Now that the Convention will come into force knowledgeable observers confidently expect that other important trading partners of the United States will become parties to the Sales Convention.¹

For readers who wish to learn more about the Convention I have prepared the following bibliography.² It collects English-language commentaries on the Sales Convention, together with an incomplete listing of non-English materials set out at the end. The most useful, longer introduction to the Convention is J. HONNOLD, *UNIFORM LAW FOR INTERNATIONAL SALES UNDER THE 1980 UNITED NATIONS CONVENTION* (1982), which includes the essential texts in its appendices. Of the shorter introductions, see Winship, *New Rules for International Sales*, 68 A.B.A.J. 1230-1234 (1982), and Winship, *International Sales Contracts Under the 1980 Vienna Convention*, 17 U.C.C. L.J. 55-71 (1984). The *International Lawyer* published a symposium on the Convention at 18 INT'L LAW. 3-56 (1984). Any serious study of the Convention will require access to the official records of the 1980 diplomatic conference in Vienna at which the text of the Convention was adopted.³

CONVENTION TEXT

1. *Official Text.* The official text appears in Annex I of the Final Act of the 1980 Vienna conference (U.N. Doc. A/CONF.97/19 (1980)). The Convention text in the six official United Nations languages (Arabic, Chinese, English, French, Russian, and Spanish) has been printed and is available from the Treaty Section of the Office of Legal Affairs at the United Nations headquarters in New York. The text also appears in the official records of the Vienna conference: UNITED NATIONS CONFERENCE ON CONTRACTS FOR THE INTERNATIONAL SALE OF GOODS—OFFICIAL RECORDS 178-190 (1981). The U.S. Department of State has published the U.N.-certified English text in 52 FEDERAL REGISTER 6264-2, (1987).⁴

2. *German Text.* German-speaking countries have agreed upon a uniform German translation of the Convention text.
