The text of the six official language versions of the convention (Arabic, Chinese, French, Russian, and Spanish) are reproduced in R. KATHREIN & D. MAGRAW eds., *THE CONVENTION FOR THE INTERNATIONAL SALE OF GOODS: A HANDBOOK OF BASIC MATERIALS* (Chicago: A.B.A. Section of Int'l Law & Practice, 1987), and in C. BIANCA & M. BONELL eds., *COMMENTARY ON THE INTERNATIONAL SALES LAW: THE 1980 VIENNA SALES CONVENTION* (Milan: Giuffr , 1987).

Unofficial translations of the convention into German and Italian are also published in the C. BIANCA & M. BONELL volume cited *supra*. The German translation is the uniform text agreed upon by the German-speaking countries.

The English text is published in the Appendix to Title 15 of the UNITED STATES CODE ANNOTATED (Supp. 1987), together with the Message Accompanying Transmittal from President Reagan to the Senate (Treaty Doc. No. 98-9) (1983).
