WEDNESDAY—MARCH 18

The Symposium will open with registration and a commencement speech at the banquet.

THURSDAY—MARCH 19

The Symposium will focus on the practical application of air law to aircraft accidents. The first day's presentation will begin with the accident inquiry from both plaintiff's and defendant's view as well as that of the NTSB. A later session will feature the impact of the Tyding's Bill now before Congress and the discovery process, including whether the NTSB hearing should be conducted in an adversary manner or one in which probable cause and not proximate cause is the only fact in issue.

FRIDAY—MARCH 20

The second day's subject will be concerned with the litigation process and will include both foreign and domestic litigation procedures. Again the discussion will include both plaintiff's and defendant's position. A panel discussion will close out the Symposium.
