WEDNESDAY—MARCH 18

The Symposium will open with registration and a commencement speech at the banquet.

THURSDAY—MARCH 19

The Symposium will focus on the practical application of air law to aircraft accidents. The opening day's presentation will begin with the morning session considering the accident investigation procedure. Speakers' topics will include the NTSB's investigation and hearing; military investigations and reports; and investigation by the Air Transport Association. Limitation of Liability by Treaty and Statute will be the luncheon subject. The second session will be Part I of Preparation Prior to Trial and will consist of speeches on discovery, strategy, and a panel discussion on voice and flight recorders.

FRIDAY—MARCH 20

Session I is titled Preparation Prior to Trial, Part II and Trial. Subjects included are: Accident Reconstruction and Use of Experts; Problems and Profits in Multi-Plaintiff Actions; Defendant Counsel Considerations; and Products Liability—Current Developments. The luncheon topic will be the Tydings' Bill. The final session will be a discussion of foreign investigation procedure and a summary of the Symposium. A panel will round out the Symposium by answering questions from the delegates.
