Official annual publication of AIA. Contents vary from that usually included in this yearbook. Aviation development of the year is concisely covered in about 25 pages and the remaining text includes reproduction of official reports of the President's Air Policy Commission and the Congressional Aviation Policy Board and "Elements of air power" which is a compilation of the summaries of the statements of 17 aircraft companies before the PAPC.

"Essentially the industry sells but one commodity—speed . . . has the industry ever really made a concerted effort to determine how much of its potential market actually demands 'ever increasing speed' . . . We think not." Presents a new basis for determining potential air travel.

A documented study covering the last twenty years. Annexes contain pertinent League of Nations documents, and publications of the International Civil Aviation Conference and ICAO.

Fuller, J. F. C. THE SECOND WORLD WAR 1939-1945, A STRATEGICAL AND TACTICAL HISTORY. New York, Duell, Sloan and Pearce, 1949. 431 p. \$5.00.

An important statement of the place of airpower in military operations, particularly in the light of the present controversy over the size and nature of America's Air Force. Gen. Fuller objects to Churchill's and America's concept of strategic bombing; that is, saturation bombing of population centers with its wanton destruction of life and property. He maintains that the place of airpower in the strategy of war is to help annihilate the enemy's forces 1) by providing swifter and surer striking power, and 2) by depriving the enemy of mobility through destroying his air power and his transport and communication centers.

An introductory section describes the major trends in popula-

tion and employment, and in the broad industrial and occupational groups. Illustrated with 47 charts and 79 photographs.

Several interesting chapters in Part V discuss the solving of Naval Aviation's problems of training, man-power, production, expansion of shore establishments, repair facilities, transport, and scientific research.
