The Internship Program sponsored by the School of Law is now in its third year and the splendid cooperation received from numerous Dallas attorneys has again assured its success. Under the faculty direction of Professor Charles O. Galvin, students who have completed two years of legal training are placed in law firms, corporations, and public offices for three months of practical experience, supplemented by informative lectures on the practice of law once each week. Twenty students are engaged in the training program this summer.

The Law School is fortunate, during the summer term, in having Professor Harold G. Wren, of the University of Oklahoma, as Visiting Professor of Law. He is a graduate of Columbia Law School, was a Sterling Fellow at Yale, and more recently a Fulbright Research Scholar in Tokyo. While at S.M.U. he is teaching the courses in Restitution and Legal Accounting.

Professors Alfred Hill and Charles O. Galvin have both been granted a one-year leave of absence. Professor Hill will be a visiting professor at Northwestern School of Law. Professor Galvin will be the Ezra Ripley Thayer Teaching Fellow at Harvard Law School. The staff of the *Journal* looks forward to their return in the fall of 1957.

Several books have recently been either authored or edited by members of the law school faculty. Professor A. J. Thomas and his wife, Mrs. Ann Van Wynen Thomas, are the authors of *NON-INTERVENTION: THE LAW AND ITS IMPORT IN THE AMERICAS*, which explores and analyzes the international legal principle of non-intervention in all its implications and aspects. The book was published by the S.M.U. Press.

Professor Roy R. Ray, in conjunction with Professor William F. Young, Jr., of the University of Texas, has just completed the second edition of McCormick and Ray, *THE TEXAS LAW OF EVIDENCE*. The publisher is Vernon Law Book Company.

Professor Arthur L. Harding has edited and prepared the third in the series of Jurisprudence publications entitled *RELIGION, MORALITY AND LAW*, which contains essays by Robert E. Fitch, Joseph D. Quilliam, Wilber G. Katz, and Professor Harding. The book has been published by the S.M.U. Press.
