The S.M.U. School of Law Moot Court Team—composed of David Musselwhite; Associate Editor, Neil Weatherhogg; and Ronald W. Turley—won the National Moot Court Competition in New York City in December. Earlier, the team won the regional competition, which was held at Southern Methodist University. The team was coached this year by Professor Harvey Davis and Professor William VanDercreek. At the national competition, the S.M.U. team switched sides in each round of the competition and defeated St. Louis University, University of Wisconsin, New York University, and Washington University of St. Louis. The team brief won third place in the national competition, and David Musselwhite was selected as the top speaker in the final round.
