Announcement of awards and prizes for outstanding work by members of the Student Editorial Board was made on November 19, 1953. A cash award of \$100 has been made to Armine C. Ernst of Seguin, Texas, by the law firm of Thompson, Knight, Wright, Weisberg & Simmons, Dallas, Texas, for the best original comment published in the *Journal* during the past year. Her comment appears at page 280 of the current volume. She also prepared the Index to Volume 6 and a Survey note at page 314 in Volume 6.

Benton Musslewhite of Lufkin, Texas, and Charles G. Thrash, Jr., of Dallas, Texas, are the joint recipients of a cash award of \$100 from the law firm of Turner, Atwood, White, McLane & Francis, Dallas, Texas, for the best contributions to the Survey issue of the *Journal*. Their respective contributions appear at pages 379 and 407 of this volume.

W. Dawson Sterling of Dallas, Texas, has been awarded a cash prize of \$100 by the law firm of Butler, Binion, Rice & Cook of Houston, Texas, for preparing the best paper on a subject approved by the professor of the course in Insurance. Technical problems arising out of the Taft-Hartley Act were discussed the first day, and on the second day labor arbitration was the topic of discussion. An excellent attendance was had (around 150 registrants), and the interest and attention of the audience was marked.
